Box 30232, Lansing, MI 48909. The petition must be filed on a Michigan Tax Tribunal form or a form approved by the Michigan Tax Tribunal. Michigan Tax Tribunal forms are available at www.michigan.gov/taxtrib.

**Note:** The Petition for Change of Property Classification form and supporting documentation is the only information that will be considered by the State Tax Commission for review of this classification appeal, as in accordance with MCL 211.34c which states: "The State Tax Commission shall arbitrate the petition based on the written petition and the written recommendations of the assessor and the State Tax Commission staff." **Property Owners will not be afforded an opportunity to present their appeal in person.**
